CARLOS F.M. PACHECO NO DISTRICT
("Applicant") (Namely Application No.)

filed on the 29TH day of JUNE, 1977; and

WHEREAS, The Enrollment Committee has reviewed the application and has recommended that the application be denied because the applicant failed to establish the following membership requirement(s): TOHONO O'ODHAM CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

WHEREAS, The application has come on for hearing before this Council; and

WHEREAS, The Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Enrollment Ordinance, upon the person who filed the application and such person was/was not present at this hearing; and

WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented and from such evidence finds that the applicant has failed to establish the foregoing membership requirement(s).

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby determine that the application of:

CARLOS F.M. PACHECO

for enrollment as a member of the Tohono O'odham Nation is hereby rejected.


BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of of the Enrollment Ordinance.




