

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Employees receiving below the average wage of \$12,483 shall receive an additional 2½% Cost of Living Increase)

RES. NO. 245-86

1 WHEREAS, By Resolution No. 244-86 the Tohono O'odham Legislative Council did
2 grant a Cost of Living Increase to all employees of the Tohono O'odham
3 Nation, effective October 01, 1986; and

4
5 WHEREAS, The Council believes that employees earning less than the average wage
6 of \$12,483 per year should receive an additional Cost of Living
7 Increase.

8 NOW, THEREFORE, BE IT RESOLVED by the Council that employees of the Tohono
9 O'odham Nation, who receive a wage below the average wage of \$12,483
10 per year should receive a 2½% Cost of Living Increase at an estimated
11 additional annual cost of \$28,400, effective October 01, 1986, in
12 addition to the Cost of Living Increase provided for in Resolution
13 Number 244-86.

15 The foregoing resolution was passed by the Tohono O'odham Council on the 11th
16 day of April, 1986, at a meeting at which a quorum was present with a vote of
17 1112.0 for; 528.0 against; -0- not voting; and -02- absent, pursuant to the
18 powers vested in the Council by Section 1 (d) of Article VI of the Constitution
19 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
20 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
21 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
22 June 18, 1934 (48 Stat. 984).
