Harvey for the position of Usagakam of the Tohono O'odham Judiciary and finds him to be qualified for the position.

NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby appoint Donald Harvey as Usagakam of the Tohono O'odham Judiciary.

The foregoing resolution was passed by the Tohono O'odham Council on the  $\underline{5th}$  day of  $\underline{May}$ , 1986, at a meeting at which a quorum was present with a vote of  $\underline{1099.0}$  for;  $\underline{541.0}$  against;  $\underline{-0-}$  not voting; and  $\underline{03}$  absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI and Section 3 and 4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
