
1 WHEREAS, Article VIII, Section 3 and Section 4 of the Constitution of the
2 Tohono O'odham Nation empowers this Council to appoint the U'usagakam
3 of the Tohono O'odham Judiciary; and

4 WHEREAS, The Council has reviewed the application and qualifications of Donald
5 Harvey for the position of Usagakam of the Tohono O'odham Judiciary
6 and finds him to be qualified for the position.

8 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby appoint
9 Donald Harvey as Usagakam of the Tohono O'odham Judiciary.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
11 day of May, 1986, at a meeting at which a quorum was present with a vote of
12 1099.0 for; 541.0 against; -0- not voting; and 03 absent, pursuant to the
13 powers vested in the Council by Section 1 (b) of Article VI and Section 3 and
14 4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by
the Tohono O'odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
