

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting terms of office of appointed U'usagakam of Tohono
O'odham Judiciary)

RES. NO. 251-86

1 WHEREAS, This Council did by Resolutions No. 248-86, 249-86 and 250-86, re-
2 spectively appoint Donald Harvey, Malcolm Escalante and Larry Garcia
3 as full time U'usagakam of the Tohono O'odham Judiciary; and

4 WHEREAS, Article VIII, Section 4, sets the terms of office of the U'usagakam
5 at six years, provided, however, the their terms must be staggered so
6 that approximately one-third of the U'usagakam will be appointed every
7 other year; and

8 WHEREAS, It is therefore incumbent upon the Council to designate specific
9 staggering terms for the three U'usagakam.

10 NOW, THEREFORE, BE IT RESOLVED by the Council that the terms of office of the
11 three U'usagakam shall be as follows:


12 Larry Garcia - 6 years

13 Malcolm Escalante - 4 years


14 Donald Harvey - 2 years

15 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
16 day of May, 1986, at a meeting at which a quorum was present with a vote of
17 1444.0 for; 117.0 against; 79.0 not voting; and 03 absent, pursuant to the
18 powers vested in the Council by Section 1 (b) of Article VI and Section 3 and
19 4 of Article VIII of the Constitution of the Tohono O'odham Nation, adopted by
20 the Tohono O'odham Nation on January 18, 1986, and approved by the Acting
21 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
