

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(Seating Representative and Alternate from
Pisinemo District)

RES. NO. 252-86

1 WHEREAS, Sylvester Manuel, the successor primary representative from the
2 Pisinemo District to the Tohono O'Odham Council, has resigned his
3 office on such representative; and

4 WHEREAS, Both the offices of the primary representative and of his alternate
5 became vacant upon such resignation and the Pisinemo District Council
6 did on April 9, 1986, appoint Jerome Antone and Connie Mendoza as rep-
7 resentative to this Council in accordance with the provisions of
8 Article XII, Section 2 (c) of the Constitution of the Tohono O'Odham
9 Nation, each to hold office for the unexpired term of their pre-
10 decessor.

12 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby certify to
13 the appointment of, and does hereby seat (1) Jerome Antone as repre-
14 sentative to this Council from the Pisinemo District and (2) Connie
15 Mendoza alternate to this Council from the Pisinemo District, each to
16 hold office for the unexpired term of their predecessors Sylvester
17 Manuel and Chester Antone.

19 The foregoing Resolution was passed by the Tohono O'Odham Council on the 7th
20 day of May, 1986, at a meeting at which a quorum was present with a vote of
21 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
22 vested in the Council by Section 1 (g) and (e) of Article VI of the Consti-
23 tution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
24 January 18, 1986, and approved by the Acting Deputy Assistant Secretary-Indian
25 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
26 June 18, 1934 (48 Stat. 984).




