

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(Accepting resignations from Council)

RES. NO. 254-86

1 WHEREAS, The Tohono O'Odham Legislative Council did by Resolution No. 228-86
2 direct that all primary representatives and their alternates on this
3 Council who also hold office or representatives or alternates on a
4 District Council shall submit their resignation from one of these
5 Councils by May 7, 1986, in conformity with the mandate of Article X,
6 Section 3 of the Constitution; and

8 WHEREAS, The Council has received evidence of resignations by most, but not
9 all, of the representatives and alternates who hold elective public
10 office on both Councils and it is necessary for the Council to take
11 action.

12 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby approve and
13 accept the resignations rendered to date by the representatives and
14 alternates presently holding elective public office on both this
15 Council and a District Council, respectively from this Council or from
16 the District Council.

18 BE IT FURTHER RESOLVED that those representatives and alternates who presently
19 hold elective office on both this Council and a District Council and
20 who have to date failed to resign from one of these Councils shall be
21 deemed to have resigned from this Council.

22 The foregoing Resolution was passed by the Tohono O'Odham Council on the 7th
23 day of May, 1986, at a meeting at which a quorum was present with a vote of
24 665.5 for; 985.5 against; 69.0 not voting; and -0- absent, pursuant to the
25 powers vested in the Council by Section 1 (a) and (1) of Article VI of the Con-
26 stitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
27 January 18, 1986, and approved by the Acting Deputy Assistant Secretary-Indian
28 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
29 June 18, 1934 (48 Stat. 984).
