

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL
(Accepting Chukut Kuk District Budget Amendment FY '86)

1 WHEREAS, The Chukut Kuk District Council did meet on March 26, 1986 and
2 approved per diem to be paid to the Chukut Kuk District Committee
3 members at the rate of twenty five dollars (\$25.00) per member, per
4 meeting, in addition the Secretary of the District shall be included


7 WHEREAS, The Chukut Kuk District has sufficient funds in its I.I.M. Account to
8 meet this added cost; and

9 WHEREAS, The Tohono O'Odham Legislative Council approved the Chukut Kuk Dist-
10 rict budget amendment in the amount of ten thousand eight hundred
11 (\$10,800.00) increasing the FY-1986 Budget to three hundred sixteen
12 thousand three hundred six (\$316,306.00).


13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it hereby
14 approves the amendment to the Chukut Kuk District FY-1986 budget in
15 the amount of ten thousand eight hundred dollars (\$10,800), which will
16 be sufficient to end FY-1986.

18 The foregoing Resolution was passed by the Tohono O'Odham Council on the 7th
19 day of May, 1986, at a meeting at which a quorum was present with a vote of
20 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
21 vested in the Council by Section 1 (d) of Article VI of the Constitution of the
22 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986
and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Oper-
ations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).
