rollment Committee and the evidence submitted in support of the individual application.

is hereby approved and is hereby adopted into membership of the Tohono O'odham Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the 8thday of May, 1986, at a meeting at which a quorum was present with a vote of 1397.0 for; $\underline{-0}$ against; $\underline{243.0}$ not voting; and $\underline{02}$ absent, pursuant to the powers vested in the Council by Section 2 of Article II and Article VI Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
