19 Constitution of the Tohono O'odham Nation, and that their applications
20 are approved, as herein above indicated.

21 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
22 the Tohono O'odham Nation reduce this final determination in writing
23 regarding each of the foregoing applications for enrollment in ac-
24 cordance with Section 3 (c) of Article III of the Enrollment Ordi-
25 nance; give notice of this Council's determination in accordance with
26 Section 4 of Article III of the Enrollment Ordinance; and place the
27 names of each applicant upon the membership roll of the Tohono O'odham
28 Nation in accordance with Aritcle V of the Enrollment Ordinance.

32 day of May, 1986, at a meeting at which a quorum was present with a vote of
1514.0 for; -0- against; 126.0 not voting; and 02 absent, pursuant to the
