1 WHEREAS, ENAS, Burleigh G.; THROSSELL, Ruth E. (JOSE); JACKSON, Karen J.; MILES,  
2 Sharon (LEWIS): have by the attached statements relinquished their  
3 membership in the Tohono O'odham Nation.

5 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does  
6 hereby recognize that ENAS, Burleigh G.; THROSSELL, Ruth E. (JOSE);  
7 JACKSON, Karen J.; MILES, Sharon (LEWIS); have renounced membership in  
8 the Tohono O'odham Nation, and does hereby order that their names be  
9 deleted from the membership roll.

11 The foregoing resolution was passed by the Tohono O'odham Council on the 8th day  
12 of May, 1986, at a meeting at which a quorum was present with a vote of 1577.0  
13 for; -0- against; 63.0 not voting; and 02 absent, pursuant to the powers vested  
14 in the Council by Section 3 of Article II and Article VI Section 1 (h) of the  
15 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
16 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
18 of June 18, 1934 (48 Stat. 984).
