1	WHEREAS,	the qualified voters of the Tohono O'odham Nation did

14	WHEREAS,	the Constitution consequently mandates that enrolled
15		members of this Nation who are also enrolled as members
16		in another Indian nation, tribe, community or band must
17		be given an opportunity to elect whether they wish to

20		their membership in this Nation; and
21	WHEREAS,	the existing ordinance does not provide a procedure
22		which gives dual enrollees the opportunity to make such

1983, P.L. 97-408, 96 Stat. 2038, will be distributable 1 to all enrolled members of the Nation; and 2 WHEREAS, the Council finds that such per capita distributions 3 should not be made until all members of this Nation who 4 are also enrolled in another nation, tribe, community 5 or band have either relinquished their membership in 6 such nation, tribe, community or band or have had their 7 8 names removed from this Nation's roll. NOW, THEREFORE, BE IT RESOLVED by the Council that is does 9 hereby amend the existing enrollment ordinance, Papago 10 Enrollment Ordinance No. 5-81, by adding thereto the 11 attached new Article IX, entitled RELINQUISHMENT AND 12 LOSS OF MEMBERSHIP; by renumbering the existing Article 13 IX, entitled MISCELLANEOUS; CERTIFIED COPIES; PENAL-14 TIES, as Article X; and by changing the references 15 therein from "Papago" to "Tohono O'odham," from "Tribe" 16 to "Nation," from "Papago Indian blood" to "Papago-17 Tohono O'odham Indian blood," and from the "Papago 18 Constitution" to "Constitution of the Tohono O'odham 19 Nation." 20BE IT FURTHER RESOLVED that all dual enrollees be advised forth-21 with of their rights under the new Constitution and the $\mathbf{22}$ enrollment ordinance as amended, and that the final $\mathbf{23}$ installment of per capita distributions payable under 24 Section 8(c)(3)(iii) of the Act of January 3, 1983, 25 P.L. 97-408, 96 Stat. 2038, be deferred until their 26enrollments have been reviewed and acted upon accord- $\mathbf{27}$ ingly. 28 The foregoing resolution was passed by the Tohono O'odham Coun-29 cil on the

ARTICLE IX - RELINQUISHMENT AND LOSS OF MEMBERSHIP

Section 1 Relinquishment of Membership

A member of the Nation may relinquish his membership in the Nation by submitting a written statement clearly expressing an intent to relinquish his membership to the Council, a copy of which must be served on the committee. The written statement must be signed by the person wishing to relinquish his membership or, if a minor or incompetent, by the parent(s), guardian or other person legally authorized to act on his behalf. Relinquishment does not require the approval of the Council, but is effective upon receipt of the statement by the Council and cannot be subsequently denied. Upon recognition by the Council that the individual has renounced his membership, his name shall be deleted from the membership roll.



Membership in the Nation and all rights deriving there-from shall be lost or abandoned if a person is or be comes enrolled as a member in another Indian nation, tribe, community or band. Whenever the committee determines that a person who is a member of the Nation or qualifies for membership in the Nation is or becomes enrolled as a member of another Indian nation, tribe, community or band, the committee shall notify such person that he must either relinguish his membership in such other Indian nation, tribe, community or band, or relinquish or lose his membership in the Tohono O'odham Nation. If such person fails or refuses to re linguish his membership in such other Indian nation, tribe, community or band, the committee shall recommend to the Council that his membership in the Nation be declared lost and abandoned.

(A) Notice of Hearing

Whenever the committee recommends that the Counci: declare a membership to be lost or abandoned as hereinabove provided, written notice shall be given before a final determination is made by the Council. The notice shall (1) advise the person ; of the committee's recommendation; (2) fix a time and place for the Council to hold a hearing and make its final determination; (3) indicate that the person may appear before the Council at the time and place fixed for such hearing to show why his membership in the Nation and all rights deriving therefrom should not be determined to be lost or abandoned. The notice shall be given to such person or, if a minor or incompetent, to his parent(s), guardian or other person legally authorized to act on his behalf, at least 20 days prior to the time fixed for the Council to hold. a hearing to make its final determination, and shall be served by certified mail, return receipt requested, or by personal service by a member or agent of the enrollment committee who shall veri fy service of a copy of the notice by endorsing his name and date of delivery upon another copy



thereof, and by having the person served acknowledge receipt of a copy thereof by signing his name thereon. Where it appears that the notice required under this Section was deposited in a United States Post Office box more than thirty (30) days prior to the time fixed for the Council to hold its hearing and such notice was sent by certified mail as provided herein, it shall be presumed that such notice was received by the addressee more than twenty (20) days prior to the time fixed for the hearing by the Council.

The Council shall review the recommendation of the committee and determine whether the person is a member of the Nation and is or has become enrolled as a member in another Indian nation, tribe, community or band. Such person shall have the burden of proof of establishing to the satisfaction of the Council that he is not a member of such other Indian nation, tribe, community or band, and the determination of the Council shall be final unless a timely appeal is made in accordance with the appeals procedures in Subsection C of this Section Notice of the Council's determination shall be given promptly; shall be sent by certified mail, return receipt requested, addressed to such person or his parent(s), guardian or other person legally authorized to act on his behalf; and shall advise that the determination may be appealed to the Tohono O'odham Courts in accordance with the appeals procedures in Subsection C of this Section The notice shall indicate the time within which an appeal must be commenced and the procedure for commencing such appeal.

Appeal from Final Determination

Any person whose membership in the Nation has been revoked by a final determination of the Council that his membership was lost or abandoned because such person is or has become enrolled as a member of another Indian nation, tribe, community or band, may appeal such determination to the Tohono O'odham Courts. To commence an appeal such person must clearly express an intent to appeal such determination to the Tohono O'odham Courts, a copy of which must be served on the Council, before the close of business on the 30th day after the notice was received by such person unless such notice is delivered to an address outside the Continental United States in which case there shall be 60 days rather than 30 in which to file such an appeal. Upon an appeal being commenced, the Council shall transmit or make available to the Court the complete record pertaining to the determination. The burden of proof upon such person shall be to show that the Council acted arbitrarily, unreasonably or contrary to the law in making the determination. The Court will consider the record as presented, together with any legal authority that it may consider pertinent, and the Court may, in

its own discretion, allow oral argument to be made. The decision of the Tohono O'odham Courts on appeal shall be final and conclusive and written notice of the decision shall be given to such person.
