

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(San Carlos Irrigation Project)


1 WHEREAS, the Papago Tribal Utility Authority ("PTUA") plans to provide electric
2 service to the Chuichu area of this Nation presently served by the San
3 Carlos Irrigation Project, and has requested this Council to ask the
4 Secretary of the Interior to abandon and convey to this Nation title
5 to all of the electric distribution facilities of the San Carlos
6 Irrigation Project within the Nation which serve the Chuichu area
7 (except electric meters and transformers), pursuant to the provisions
8 of 25 U.S.C. §443 (a) or other applicable laws, and, upon such con-
9 veyance, to reconvey title thereto to the PTUA in order to permit the
10 PTUA effectively to serve the area; and

12 WHEREAS, the Council supports this request.

13 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby request the
14 Secretary of the Interior to abandon and convey to this Nation title
15 to all of the electric distribution facilities of the San Carlos
16 Irrigation Project within the Nation which serve the Chuichu area
17 (except electric meters and transformers), pursuant to the provisions
18 of 25 U.S.C. §443 (a) or other applicable laws, and, upon such con-
19 veyance, directs that title thereto be conveyed to the PTUA in order
20 to permit the PTUA effectively to serve the area.

22 The foregoing Resolution was passed by the Tohono O'Odham Council on the 8th
23 day of May, 1986, at a meeting at which a quorum was present with a vote of
24 1508.0 for; 63.0 against; 69.0 not voting; and -0- absent, pursuant to the
25 powers vested in the Council by Section 1 (f) of Article VI of the Consti-
26 tution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
27 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
29 of June 18, 1934 (48 Stat. 984).
