

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Delegate the Executive Branch to nominate candidates for appointment  
to the Liquor Commission)

RES. NO. 267-86

1 WHEREAS, The Tohono O'odham Council did on April 6, 1982, adopt an Ordinance  
2 alternatively prohibiting or sanctioning and licensing the intro-  
3 duction, sale, possession and consumption of alcoholic beverages  
4 within the exterior boundaries of the Tohono O'odham Nation; and



6 WHEREAS, The Ordinance requires the appointment of a 3-member Liquor Licenses  
7 and Control Commission; and

8 WHEREAS, The Council believes it to be in the best interest of the Nation that  
9 the Executive Branch submit nomination to this Council for appointment  
10 to the Commission.


11 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby request that the  
12 Executive Branch submit to this Council the names of three (3) persons  
13 for appointment to the Liquor License and Control Commission.

15 The foregoing resolution was passed by the Tohono O'odham Council on the 9th  
16 day of May, 1986, at a meeting at which a quorum was present with a vote of  
17 880.5 for; 503.5 against; 58.0 not voting; and 138.0 absent, pursuant to the  
18 powers vested in the Council by Section 1 (b) of Article VI of the Constitution  
19 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
20 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
21 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
22 June 18, 1934 (48 Stat. 984).
