

13 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
14 named applicants are eligible for enrollment as members of the
15 Papago Tribe under Section 1 (a) or (b) of Article II of the
16 Papago Constitution and By-laws, as amended, and that their
17 applications are approved, as herein above indicated.

18 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
19 the Papago Tribe reduce this final determination in writing regarding
20 each of the foregoing applications for enrollment in accordance with
21 Section 3 (c) of Article III of the Papago Tribal Enrollment Ordinance;
22 give notice of this Council's determination in accordance with
23 Section 4 of Article III of the Papago Tribal Enrollment Ordinance;
24 and place the names of each applicant upon the Tribal membership roll
25 in accordance with Article V of the Papago Tribal Enrollment Ordinance.

26 The foregoing Resolution was duly enacted by the Papago Council on the 5th day
27 of February, 1986, at a meeting at which a quorum was present with a vote of
28 1523.0 for; -0- against; 117.0 not voting; and 02 absent, pursuant to the au-
29 thority vested in the Papago Council by Article II and Article V, Section 2 (f)
30 of the Constitution and By-laws of the Papago Tribe of Arizona as amended, rati-
31 fied by the Papago Tribe on December 12, 1936, and approved by the Secretary of
32 the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary
of the Interior and is effective as of the date of its enactment by the Papago
Council.
