

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Appointment of Scott Hathorn, Jr. to the Papago Farm Board)

RES. NO. 269-86

1 WHEREAS, The Tohono O'odham Council did by Resolution No. 72-79, establish the  
2 Papago Farming Authority and adopt a Plan of Operation granting  
3 management power to a Management Board of eight (8) persons, five of  
4 whom must be members of the Tohono O'odham Nation and three (3) of  
5 whom must be persons having not less than ten (10) years' experience  
6 in farming or business management of substantial character; and

8 WHEREAS, The Tohono O'odham Council did on November 5, 1980, by Resolution No.  
9 121-86, appoint eight persons to the Management Board upon alternating  
10 terms; and

11 WHEREAS, Pat Garrett has resigned and it is necessary to fill the vacancy cre-  
12 ated by his resignation.

13 NOW, THEREFORE, BE IT RESOLVED that Scott Hathorn, Jr. is hereby appointed to  
14 the Management Board of the Papago Farming Authority for the unexpired  
15 term of Pat Garrett.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 9th  
18 day of May, 1986, at a meeting at which a quorum was present with a vote of  
19 1444.0 for; -0- against; 58.0 not voting; and 138.0 absent, pursuant to the  
20 powers vested in the Council by Section 1 (b) of Article VI of the Constitution  
21 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
22 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
23 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
24 June 18, 1934 (48 Stat. 984).
