

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Management of Health Services)

RES. NO. 278-86

1 WHEREAS, The Tohono O'odham Nation is presently operating the Management of
2 Health Services under FY '86 P. L. 93-638 contract with the Public
3 Health, Indian Health Service; and
4
5 WHEREAS, Such Tribal operations have been successful and beneficial to the
6 Tohono O'odham Nation and its people; and
7
8 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all
9 proposals to recontract under P. L. 93-638 be submitted to the Tohono
10 O'odham Council for approval at least 120 days prior to the contract
11 termination; and
12
13 WHEREAS, The Tohono O'odham Nation does desire to recontract for provisions of
14 these services during FY 1987; and
15
16 WHEREAS, The Tohono O'odham Council has reviewed and approved the Management of
17 Health Services contract.

19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
20 authorize and request the Public Health, Indian Health Service to
21 contract with the Tohono O'odham Nation under P. L. 93-638 regulations
22 and procedures for the provision of services titled: Management of
23 Health Services.

25 BE IT FURTHER RESOLVED that the duration of this contract will commence on
26 October 1, 1986, through September 30, 1987, unless extended by mutual
27 agreement of both parties.

29 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate
30 a program for which a contracts are requested herewith which have not
31 been negotiated and executed by the Indian Health Service prior to the
32 start of the funding year.
BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice-
Chairman or Rosita N. Ruiz, Treasurer, of the Tohono O'odham Nation
are hereby authorized to negotiate and execute these contracts and any

amendments thereto for the duration of the contract, provided however that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 19th day of May, 1986, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
