

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'odham Psychological Services)

RES. NO. 280-86

1 WHEREAS, The Tohono O'odham Nation is presently operating the Psychological  
2 Services under FY 86 P.L. 93-638 contract with the Public Health,  
3 Indian Health Service; and  
4

5 WHEREAS, Such Tribal operations have been successful and beneficial to the  
6 Tohono O'odham Nation and its people; and

7 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all  
8 proposals to recontract under P.L. 93-638 be submitted to the Tohono  
9 O'odham Council for approval at least 120 days prior to the contract  
10 termination; and

11 WHEREAS, The Tohono O'odham Nation does desire to recontract for provisions  
12 of these services during FY 1987; and  
13

14 WHEREAS, The Tohono O'odham Council has reviewed and approved the Psychological  
15 Services contract.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does  
17 authorize and request the Public Health, Indian Health Services to  
18 contract with the Tohono O'odham Nation under P.L. 93-638 regulations  
19 and procedures for the provision of services titled: Psychological  
20 Services.  
21

22 BE IT FURTHER RESOLVED that the duration of this contract will commence on  
23 October 01, 1986 through September 30, 1987 unless extended by mutual  
24 agreement of both parties.

25 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate  
26 a program from which contracts are requested herewith which have not  
27 been negotiated and executed by the Indian Health Service prior to  
28 the start of the funding year.

30 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice-  
31 Chairman or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation are  
32 hereby authorized to negotiate and execute these contracts and any

amendment. thereto for the duration of the contracts, provided how-  
ever that any amendments affecting the funding or funding levels of  
the contract shall be submitted for further prior approval by this  
Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 19th  
day of May, 1986, at a meeting at which a quorum was present with a vote of  
1514.0 for; -0- against; -0- not voting; and 126.0 absent, pursuant to the  
powers vested in the Council by Section 1 (f) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).
