

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Community Health Representative)

RES. NO. 282-86

- 1 WHEREAS, The Tohono O'odham Nation is presently operating the Community Health
2 Representative program under FY '86 P. L. 93-638 contract with the
3 Public Health, Indian Health Service; and
- 4 WHEREAS, Such Tribal operations have been successful and beneficial to the
5 Tohono O'odham Nation and its people; and
- 6 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all
7 proposals to recontract under P. L. 93-638 be submitted to the Tohono
8 O'odham Council for approval at least 120 days prior to the contract
9 termination; and

- 11 WHEREAS, The Tohono O'odham Council does desire to recontract for provisions of
12 these services during FY 1987; and
- 13 WHEREAS, The Tohono O'odham Council has reviewed and approved the Community
14 Health Representative contract.
- 15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
16 authorize and request the Public Health, Indian Health Service to
17 contract with the Tohono O'odham Nation under P. L. 93-638 regulations
18 and procedures for the provision of services titled: Community Health
19 Representative.

- 21 BE IT FURTHER RESOLVED that the duration of this contract will commence on
22 October 1, 1986, through September 30, 1987, unless extended by mutual
23 agreement of both parties.
- 24 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate
25 a program from which contracts are requested herewith which have not
26 been negotiated and executed by the Indian Health Service prior to the
27 start of the funding year.

- 29 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice-
30 Chairman or Rosita N. Ruiz, Treasurer, are hereby authorized to
31 negotiate and execute this contract and any amendments thereto for the
32 duration of the contract, provided however that any amendments

affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 19th day of May, 1986, at a meeting at which a quorum was present with a vote of 1581.5 for; -0- against; 58.8 not voting; and 04 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
