

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Johnson O'Malley)

RES. NO. 287-86

1 WHEREAS, The Tohono O'odham Nation is presently operating the Johnson O'Malley
2 under FY 1986 P. L. 93-638 contract with the Bureau of Indian Affairs;
3 and
4 WHEREAS, Such Tribal operations have been successful and beneficial to the
5 Tohono O'odham Nation and its people; and
6 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations requires that all
7 proposals to recontract under P. L. 93-638 be submitted to the Tohono
8 O'odham Council for approval at least 120 days prior to the contract
9 termination; and

11 WHEREAS, The Tohono O'odham Nation does desire to recontract for provisions of
12 these services during FY 1987; and
13 WHEREAS, The Tohono O'odham Council has reviewed and approved the Johnson
14 O'Malley contract.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
17 authorize and request the Bureau of Indian Affairs to contract with
18 the Tohono O'odham Nation under P. L. 93-638 regulations and pro-
19 cedures for the provision of services titled: Johnson O'Malley.
20 BE IT FURTHER RESOLVED that the duration of this contract will commence on
21 October 01, 1986 through September 30, 1987.
22 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not fund or operate
23 a program from which contracts are requested herewith which have not
24 been negotiated and executed by the Bureau of Indian Affairs prior to
25 the start of the funding year.

27 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice
28 Chairman or Rosita Ruiz, Treasurer, of the Tohono O'odham Nation are
29 hereby authorized to negotiate and execute these contracts and any
30 amendment thereto for the duration of the contracts, provided however,
31 that any amendments affecting the funding or funding levels of the
32 contract shall be submitted for further prior approval by this
Council.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 19th
2 day of May, 1986, at a meeting at which a quorum was present with a vote of
3 1640.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the powers
4 vested in the Council by Section 1 (f) of Article VI of the Constitution of the
5 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
6 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
8 1934 (48 Stat. 984).
