15 16	Chairman, or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation

18	amendments thereto for the duration of the grants, provided however						
19	that any amendments affecting the funding or funding levels of the						
20	grant shall be submitted for further prior approval by this Council.						
21	The foregoing resolution was passed by the Tohono O'odham Council on the 19th day of May, 1986, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and 04 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of th Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
