

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(To override veto of Resolution Numbers 248-86 through 251-86)

RES. NO. 294-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 248-86  
2 through 251-86 appoint Donald Harvey, Malcolm Escalante and Larry  
3 Garcia as U'usagakam of the Tohono O'odham Judiciary and set their  
4 terms of office; and

5  
6 WHEREAS, Upon presentation of these resolutions to the Chairman of the Tohono  
7 O'odham Nation he did disapprove thereof and returned them to the  
8 Council with his objections in accordance with the provision of Article  
9 VII, Section 5 of the Constitution of the Nation; and

10 WHEREAS, The Council has reviewed the Chairman's objections and after consider-  
11 ation again voted to pass Resolution No. 248-86 through 251-86.

13 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the  
14 Chairman's veto of Resolution No. 248-86 through 251-86.

15 The foregoing resolution was presented to the Tohono O'odham Council on the 4th  
16 day of June, 1986, at a meeting at which a quorum was present and, by a vote of  
17 259.5 for; 1164.5 against; 216.0 not voting; and -0- absent, failed to override  
18 the Chairman's veto of Resolution No. 248-86 through 251-86 pursuant to powers  
19 vested in the Council by Section 5 of Article VII of the Constitution of the  
20 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
21 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
22 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
23 1934 (48 Stat. 984).
