WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 249-86 1 2 appoint Malcolm Escalante as Usagakam of the Tohono O'odham Judiciary; 3 and 4 WHEREAS, Upon presentation of the resolution to the Chairman of the Tohono 5 O'odham Nation he did disapprove thereof and returned it to the Council 6 with his objections in accordance with the provisions of Article VII, 7 Section 5 of the Constitution of the Nation; and 8 WHEREAS, The Council has reviewed the Chairman's objections and after consider-9 10 ation again voted to pass Resolution No. 249-86. 11 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the 12 Chairman's veto of Resolution No. 249-86. 13 The foregoing resolution was presented to the Tohono O'odham Council on the 4th 14 15

day of June, 1986, at a meeting at which a quorum was present and, by a vote of 705.0 for; 814.0 against; 121.0 not voting; and -0- absent, failed to override the Chairman's veto of Resolution No. 248-86, pursuant to the powers vested in the Council by Section 5 of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
