

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(To override veto of Resolution Number 250-86)

RES. NO. 297-86


1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 250-86
2 appoint Larry Garcia as Usagakam of the Tohono O'odham Judiciary; and
3
4 WHEREAS, Upon presentation of the resolution to the Chairman of the Tohono
5 O'odham Nation he did disapprove thereof and returned it to the Council
6 with his objections in accordance with the provisions of Article VII,
7 Section 5 of the Constitution of the Nation; and

8 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
9 ation again voted to pass Resolution No. 250-86.


10 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
11 Chairman's veto of Resolution No. 250-86.

12 The foregoing resolution was presented to the Tohono O'odham Council on the 4th
13 day of June, 1986, at a meeting at which a quorum was present and, by a vote of
14 715.0 for; 563.0 against; 362.0 not voting; and -01- absent, failed to override
15 the Chairman's veto of Resolution No. 250-86, pursuant to the powers vested in
16 the Council by Section 5 of Article VII of the Constitution of the Tohono
17 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and
18 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
19 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
20 984).
