ĺ WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 255-86 2 rescind its previous Resolution No. 228-86, which required its members, 3 whether representatives or alternates, who are also elected to District offices, to either resign their District offices or face ex-5 pulsion from this Council; and 6 WHEREAS, Upon presentation of Resolution No. 255-86 to the Chairman of the 7 8 Tohono O'odham Nation he did disapprove thereof and returned it to the 9 Council with his objections in accordance with the provisions of Arti-10 cle VII, Section 5 of the Constitution of the Nation; and 11 WHEREAS, The Council has reviewed the Chairman's objections and after consider-12 ation again voted to pass Resolution No. 255-86. 13 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the 14 Chairman's veto of Resolution No. 255-86. 15 16||The foregoing resolution was presented to the Tohono O'odham Council on the 4th day of June, 1986, at a meeting at which a quorum was present and, by a vote of 17 873.0 for; 767.0 against; -0- not voting; and -0- absent, failed to override the Chairman's veto of Resolution No. 255-86 pursuant to the powers vested in 18 the Council by Section 5 of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 20. 21 TOHONO O'ODHAM LEGISLATIVE COUNCIL 22 23 24 Harriet Toro, Legislative Chairperson 25 1) to day of June, 1986.
