RES. NO. 300-86 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 268-86 2 amend the Employment Rights Ordinance, Ordinance No. 01-85, by adding 3 a new Section 18, entitled "Economic Development;" and 4 WHEREAS, Upon presentation of the Resolution to the Chairman of the Tohono 5 O'odham Nation he did disapprove thereof and returned it to the 6 Council with his objections in accordance with the provisions of Arti-7 8 cle VII, Section 5 of the Constitution of the Nation; and 9 WHEREAS, The Council has reviewed the Chairman's objections and after consider-10 ation again voted to pass Resolution No. 268-86. 11 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the 12 Chairman's veto of Resolution No. 268-86. 13 The foregoing resolution was presented to the Tohono O'odham Council on the 4th 14 day of June, 1986, at a meeting at which a quorum was present and, by a vote of 825.0 for; 815.0 against; -0- not voting; and -0- absent, failed to override 15 the Chairman's veto of Resolution No. 268-86 pursuant to the powers vested in the Council by Section 5 of Article VII of the Constitution of the Tohono 16 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and 17 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 18 984). 19
