

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Setting Council calendar and compensation)

RES. NO. 304-86

1 WHEREAS, The Executive Committee of the Tohono O'odham Legislative Council did  
2 in a report to the Council, entitled Legislative Calendar Options,  
3 recommend three alternative options for Council meeting or sessions,  
4 starting October 1, 1986; and  
5

6 WHEREAS, The Council must establish a legislative calendar and set compensation  
7 for its members in order to develop a budget for FY 1987.

8 NOW, THEREFORE, BE IT RESOLVED that the Council selects Option B, modified,  
9 however to provide for five (rather than four) legislative meeting  
10 days per month (or fifty days per year) and 130 committee meeting days  
11 per year.


12 BE IT FURTHER RESOLVED that Council members receive compensation, in form of a  
13 salary at the following rates:

14  
15 50 Legislative sessions @ \$150.00 = \$165,000  
16 130 Committee sessions @ \$75.00 = \$214,500


17 Total Annual Compensation = \$379,500

18 The foregoing resolution was passed by the Tohono O'odham Council on the 5th  
19 day of June, 1986, at a meeting at which a quorum was present with a vote of  
20 982.0 for; 536.5 against; 121.5 not voting; and 02 absent, pursuant to the  
21 powers vested in the Council by Section 1 (a) and (d) of Article VI of the  
22 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
