

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL


(Referring Justice Program Grant to Law and Order Committee)


1 WHEREAS, This day's agenda reflects review of a Justice Program Grant; and  
2 WHEREAS, The Grant has previously been referred by this Council to the Law  
3 and Order Committee for review and comment; and  
4  
5 WHEREAS, The Council has been advised that the Grant was not referred to the  
6 Committee as previously ordered.  
7 NOW, THEREFORE, BE IT RESOLVED that the Justice Program Grant is again referred  
8 to the Law and Order Committee for review and comment before it is  
9 brought to this Council for action.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 6th  
11 day of June, 1986, at a meeting at which a quorum was present with a vote of  
12 971.0 for; 402.5 against; 128.5 not voting; and 138.0 absent, pursuant to the  
13 powers vested in the Council by Section 1 (a) of Article VI of the Constitution  
14 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
15 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
16 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
17 June 18, 1934 (48 Stat. 984).
