

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Tohono O'odham Skill Center)

RES. NO. 308-86

1 WHEREAS, The U.S. Department of Education, Office of Vocational and Adult
2 Education has invited applications for grants under the Program for
3 Indian Tribes and Indian Organizations, CRDA number 84,101; and
4

5 WHEREAS, The purpose for inviting applications is to provide Federal support
6 to Indian tribes to plan, conduct and administer projects or portions
7 of projects that are authorized by and consistent with Carl D. Perkins,
8 Vocation Education Act (P.L. 98-524, 20 U.S.C. 2301 et. seg.)

9 WHEREAS, The Tohono O'odham Nation has successfully established and operated
10 the Tohono O'odham Skill Center to provide vocational training to
11 Native Americans; and

13 WHEREAS, The Tohono O'odham Nation has proposed a Grant application which will
14 provide an 18 month Grant to fund vocational training for Native
15 Americans.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
17 approve the submission of applications to the U.S. Department of Edu-
18 cation, Office of Vocational and Adult Education for a Grant under the
19 Program for Indian Tribes and Indian Organizations to provide an 18
20 month Vocational Indian Education training program through the Tohono
21 O'odham Skill Center.

23 BE IT FURTHER RESOLVED that the duration of this Grant will commence on October
24 01, 1987 through March 31, 1989, unless extended by mutual agreement
25 of both parties.

26 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Vice-
27 Chairman or Rosita N. Ruiz, Treasurer of the Tohono O'odham Nation are
28 hereby authorized to negotiate and execute this contract and any
29 amendments thereto for the duration of the Grant.

31 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
32 day of June, 1986, at a meeting at which a quorum was present with a vote of
1401.0 for; 101.0 against; -0- not voting; and 138.0 absent, pursuant to the
powers vested in the Council by Section 1 (f) of Article VI of the Constitution
