

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Administration, Children, Youth and Families)

RES. NO. 309-86

1 WHEREAS, The Tohono O'odham Nation has operated successfully a Headstart, Early
2 Childhood and Day Care program for its young members; and

3 WHEREAS, Funding for the operation of these programs has depended in large on
4 meritorious proposals by the Tohono O'odham Nation to various funding
5 agencies designed to fund programs oriented toward children; and -

7 WHEREAS, The Department of Economic Security through the Administration for
8 Children, Youth and Families provides funds for certain eligible
9 services; and

10 WHEREAS, The Tohono O'odham Nation is desirous of seeking supplemental funds
11 from the Department of Economic Security to continue operation of its
12 day care programs;

14 WHEREAS, All of the child-oriented programs have proven beneficial and valuable
15 to the Tohono O'odham, especially its young members;

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby
17 approve the proposal to the Department of Economic Security, Admin-
18 istration for Children, Youth and Families for funding in the form of
19 reimbursement for the continued operation of the day care services
20 program;

22 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Vice-
23 Chairman or Rosita N. Ruiz, Treasurer are hereby authorized and
24 directed to negotiate and execute any and all contracts, amendments
25 and documents necessary to secure funding from the Administration for
26 Children, Youth and Families.

27 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
28 day of June, 1986, at a meeting at which a quorum was present with a vote of
29 1443.5 for; -0- against; 58.5 not voting; and 138.0 absent, pursuant to the
30 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
31 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
32 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
