## RESOLUTION OF THE TOHONO O'ODHAM COUNCIL (Approving Enrollment Budget Amendment FY 86)

RES. NO. 312-86

1 WHEREAS, the Enrollment Committee has recommended an amendment to its FY 1986 2 budget in order to fund increased costs resulting from the direction 3 to the Committee contained in Council Resolution No. 262-86 to require 4 dual enrollees to relinquish their membership in any other Indian 5 nation, tribe, community or band or lose their membership in this 6 7 Nation; and 8 WHEREAS, the Council has reviewed the Committee's recommendation and concurs 9 therein. 10 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby approve the 11 amendment of the FY 1986 budget of the Enrollment Committee as set out 12 in the attached modification requisition. 13 The foregoing Resolution was passed by the Tohono O'Odham Council on the  $\underline{6th}$ 14 day of <u>June</u>, 1986, at a meeting at which a quorum was present with a vote of 1502.0 for; -0- against; -0- not voting; and 138.0 absent, pursuant to the 15 powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on 16 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 18 19 TOHONO O'ODHAM LEGISLATIVE COUNCIL 20 21 asset to Harriet Toro, Legislative Chairperson 22 13th day of June, 1988. 23 24 ATTEST: 25 26 aprilia F.
