

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Approving Vi-ikam Doag Proposal)

RES. NO. 313-86

1 WHEREAS, The Vi-ikam Doag Development Authority of the San Lucy District of the
2 Tohono O'odham Nation is, by Ordinance 01-84, authorized to pursue
3 economic development activities on behalf of its members; and
4

5 WHEREAS, The Vi-ikam Doag Development Authority is engaged in developing a
6 cottage industry to secure work contracts to provide jobs and income
7 for the District; and

8 WHEREAS, The Authority has to date successfully secured several work contracts
9 for that purpose from Hughes Aircrafts Company and has also obtained
10 Bureau of Indian Affairs H50G14205879 to support that industrial
11 effort; and

13 WHEREAS, The Authority now proposes to expand its level of activity by building
14 a manufacturing facility and securing a higher level of work contracts
15 through a new project and a new Authority for-profit subsidiary: San
16 Lucy Defense Support Industries, Inc.

17 NOW, THEREFORE, BE IT RESOLVED by the Council that the Authority be given every
18 assistance by the Tribal Administrative staff, and the Bureau of Indi-
19 an Affairs in obtaining prompt, maximum dollar and program value from
20 BIA Grant H50G14205879, consistent with necessary federal regulations.

22 BE IT FURTHER RESOLVED that the Council supports the Authority's new project
23 and subsidiary, such that the Authority is authorized, through the
24 Tohono O'odham Nation, to apply for a \$166,666. Bureau of Indian Af-
25 fairs Economic Development Grant under Public Law 98-449, with grant
26 match as follows: a) \$500,000. - outside private sector/federal con-
27 tracts in manufacturing from such firms as Hughes Aircraft Corporation,
28 IBM, McDonnell Douglas Helicopter Corporation, or federal government
29 8a contracts over two years; b) District cash - \$15,105. over two
30 years; c) in kind - \$101,500. in District assets.

32 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
day of June, 1986, at a meeting at which a quorum was present with a vote of

1 1502.0 for; -0- against; -0- not voting; and 138.0 absent, pursuant to the
2 powers vested in the Council by Section 1 (j) of Article VI of the Constitution
3 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
4 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
5 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
6 June 18, 1934 (48 Stat. 984).
