## RESOLUTION OF THE TOHONO O'ODHAM COUNCIL (Revocation of Membership in Tohono O'Odham Nation)

RES. NO. 320-86

WHEREAS, Article II, Sec. 3 of the Constitution of the Tohono O'Odham Nation provides that membership in the Nation, and all rights deriving therefrom, shall be lost or relinquished if a person is or becomes enrolled as a member in another Indian nation, tribe, community or band; and WHEREAS, the Enrollment Committee has determined that the following person(s) who are enrolled as members of the Tohono O'Odham Nation are also enrolled as member(s) in another Indian nation, tribe, community or band, namely:

WHEREAS, the Enrollment Committee did serve notice upon the foregoing person(s)

that they must either relinquish membership in such other Indian

nation, tribe, community or band, or relinquish or lose membership in

the Tohono O'Odham Nation in accordance with the provisions of Art. IX

Sec. 2 of the Enrollment Ordinance; and

WHEREAS, the foregoing person(s) did not relinquish membership in such other

Indian nation, tribe, community or band, and the Enrollment Committee

has therefore recommended that their membership in this Nation be re
voked by this Council; and

WHEREAS, the Enrollment Committee did serve written notice of its recommendation upon the foregoing person(s) or, if a minor or incompetent, upon their parent(s), guardian or other person legally authorized to act on their behalf, as required by Art. IX, Sec. 2 of the Enrollment Ordinance, and this Council has reviewed the Committee's recommendation and all evidence presented, and from such evidence finds that the foregoing person(s) are enrolled as members of this Nation and are also enrolled as members of another Indian nation, tribe, community or band; that they were given an opportunity to relinquish membership in such other nation, tribe, community or band as required by Art. II,

NO. 320-86 (Revocation of Membership in Tohono O'Odham Nation) Page Two (2) Sec. 3 of the Constitution of the Tohono O'Odham Nation but have 1 failed or refused to do so, and that their membership in the Tohono 2 O'Odham Nation must therefore be revoked. 3 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that 4 5 it does hereby revoke the membership in this Nation of the foregoing 6 person() and that the Enrollment Committee serve notice of this de-7 termination in accordance with Art. IX, Sec. 2 of the Enrollment 8 Ordinance. 9 BE IT FURTHER RESOLVED that, upon completion of all appeals from this determi-10 nation or upon expiration of the time allowed for such appeals, as 11 provided in Art.
