WHEREAS, Title II of the Indian Child Welfare Act of 1978 provides
funds for development of child welfare programs under
specified terms and conditions; and

WHEREAS, The incidence of teenage parents on the Papago
Reservation is high and school based day care and after school care is not available to this group; and WHEREAS, The Papago Human Service department is capable of developing and administering day care program that will focus on keeping teenage parents in school and provide

educational component to increase parent skills; and WHEREAS, The need for such a program is well documented and Papago Human Services is capable of implementing the programs.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby approve the application of the Papago Human Services a three year Title II grant to develop and implement a Teen Parent school based Day Care and decrease the incidents of child abuse and neglect and decrease school drop-outs of teen parents through a school based day care program with educational and social service component.

BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco
Jose, Jr., Vice Chairman or Rosita Ruiz, Treasurer, of
the Papago Council is hereby authorized to negotiate
and execute this Grant and any amendments thereto for
