6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
7 the Tohono O'odham Nation reduce this final determination in writing
8 regarding each of the foregoing applications for enrollment in ac-
9 cordance with Section 3 (c) of Article III of the Enrollment Ordinance;
10 give notice of this Council's determination in accordance with
11 Section 4 of Article III of the Enrollment Ordinance; and place the
12 names of each applicant upon the membership roll of the Tohono O'odham
13 Nation in accordance with Article V of the Enrollment Ordinance.

15 The foregoing resolution was passed by the Tohono O'odham Council on the 13th
16 day of June, 1986, at a meeting at which a quorum was present with a vote of
17 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
18 vested in the Council by Section 1 of Article II and of Section 1 (h) of
19 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
20 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
21 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
22 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
