	and securities of the United States; and

WHEREAS, The Act provides that the Governing Body of the Nation, as trustee for the Nation, may only spend the interest and dividends accruing on the sum held and invested and such income can only be used for subjugation of Land, development of water resources, and construction, operation, maintenance, and replacement of related facilities on the Tohono O'odham Reservation which are not the obligation of the United States under this or any other Act of Congress; and

WHEREAS, On August 4, 1983 the Tohono O'odham Legislature enacted Ordinance No. 03-83 entitled "Ordinance of the Papago Tribal Council Creating Papago P.L. 97-293 Trust", where in it appointed the Chairman, Treasurer and Comptroller of the Nation to serve as a standing trust investment committee; and

WHEREAS, The Tohono O'odham Legislature has not recently been informed as to the total interest income that has accrued to this trust fund or the amount of trust income that has been spend therefrom.

NOW, THEREFORE, BE IT RESOLVED that this Legislature request that the Treasurer and or the Comptroller of the Nation prepare and present a oral accounting of the income and expenditure to and from this Public Law 97-293 trust account to this Legislature on the 2nd day of July, 1986 or soon thereafter.
