

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Request the Treasurer to make a verbal report to this Council  
on all expenditures of the Trust Income on July 2nd)

RES. NO. 342-86

1 WHEREAS, Section 309 of the Sothern Arizona Water Rights Settlement Act of  
2 1982, Public Law 97-293 required the Secretary of the Treasury to pay  
3 to the Governing Body of the Tohono O'odham Nation the sum of  
4 \$15,000,000 to be held in trust for the benefit of the Nation and in-  
5 vest in interest bearing deposits and securities, including deposits  
6 and securities of the United States; and  
7

8 WHEREAS, The Act provides that the Governing Body of the Nation, as trustee for  
9 the Nation, may only spend the interest and dividends accruing on the  
10 sum held and invested and such income can only be used for subjugation  
11 of Land, development of water resources, and construction, operation,  
12 maintenance, and replacement of related facilities on the Tohono  
13 O'odham Reservation which are not the obligation of the United States  
14 under this or any other Act of Congress; and

16 WHEREAS, On August 4, 1983 the Tohono O'odham Legislature enacted Ordinance No.  
17 03-83 entitled "Ordinance of the Papago Tribal Council Creating Papago  
18 P.L. 97-293 Trust", where in it appointed the Chairman, Treasurer and  
19 Comptroller of the Nation to serve as a standing trust investment  
20 committee; and  
21

22 WHEREAS, The Tohono O'odham Legislature has not recently been informed as to  
23 the total interest income that has accrued to this trust fund or the  
24 amount of trust income that has been spend therefrom.

25 NOW, THEREFORE, BE IT RESOLVED that this Legislature request that the Treasurer  
26 and or the Comptroller of the Nation prepare and present a oral ac-  
27 counting of the income and expenditure to and from this Public Law  
28 97-293 trust account to this Legislature on the 2nd day of July, 1986  
29 or soon thereafter.

31 The foregoing resolution was passed by the Tohono O'odham Council on the 1st  
32 day of July, 1986, at a meeting at which a quorum was present with a vote of  
1289.0 for; -0- against; 213.0 not voting; and 138.0 absent, pursuant to the  
powers vested in the Council by Section 1 (d)(2) of Article VI of the
