

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL  
(Revocation of Membership from Tohono O'Odham Nation)

RES. NO. 344-86

1 WHEREAS, Article II, Sec. 3 of the Constitution of the Tohono O'Odham Nation  
2 provides that membership in the Nation, and all rights deriving there-  
3 from, shall be lost or relinquished if a person is or becomes enrolled  
4 as a member in another Indian nation, tribe, community or band; and

5 WHEREAS, the Enrollment Committee has determined that the following person(s)  
6 who are enrolled as members of the Tohono O'Odham Nation are also  
7 enrolled as member(s) in another Indian nation, tribe, community or  
8 band, namely:

15 WHEREAS, the Enrollment Committee did serve notice upon the foregoing person(s)  
16 that they must either relinquish membership in such other Indian  
17 nation, tribe, community or band, or relinquish or lose membership in  
18 the Tohono O'Odham Nation in accordance with the provisions of Art. IX  
19 Sec. 2 of the Enrollment Ordinance; and

20 WHEREAS, the foregoing person(s) did not relinquish membership in such other  
21 Indian nation, tribe, community or band, and the Enrollment Committee  
22 has therefore recommended that their membership in this Nation be re-  
23 voked by this Council; and

24 WHEREAS, the Enrollment Committee did serve written notice of its recommend-  
25 ation upon the foregoing person(s) or, if a minor or incompetent, upon  
26 their parent(s), guardian or other person legally authorized to act on  
27 their behalf, as required by Art. IX, Sec. 2 of the Enrollment Ord-  
28 inance, and this Council has reviewed the Committee's recommendation  
29 and all evidence presented, and from such evidence finds that the  
30 foregoing person(s) are enrolled as members of this Nation and are


1 also enrolled as members of another Indian nation, tribe, community or  
2 band; that they were given an opportunity to relinquish membership in  
3 such other nation, tribe, community or band as required by Art. II,  
4 Sec. 3 of the Constitution of the Tohono O'Odham Nation but have  
5 failed or refused to do so, and that their membership in the Tohono  
6 O'Odham Nation must therefore be revoked.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that  
8 it does hereby revoke the membership in this Nation of the foregoing  
9 person(s) and that the Enrollment Committee serve notice of this de-  
10 termination in accordance with Art. IX, Sec. 2 of the Enrollment  
11 Ordinance.


13 BE IT FURTHER RESOLVED that, upon completion of all appeals from this determi-  
14 nation or upon expiration of the time allowed for such appeals, as  
15 provided in Art. IX, Sec. 2 of the Enrollment Ordinance, the names of  
16 the foregoing person(s) who failed to appeal or to succeed in their  
17 appeal shall be removed from the membership roll of the Tohono O'Odham  
18 Nation.

20 The foregoing resolution was passed by the Tohono O'Odham Council on the 02nd  
21 day of July, 1986, at a meeting at which a quorum was present with a vote of  
22 1113.5 for; 268.0 against; 258.5 not voting; and -0- absent, pursuant to the  
23 powers vested in the Council by Section 1 (h) of Article VI of the Constitution  
24 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January  
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).
