24 Constitution of the Tohono O'odham Nation, and that their applications  
25 are approved, as herein above indicated.

26 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
27 the Tohono O'odham Nation reduce this final determination in writing  
28 regarding each of the foregoing applications for enrollment in ac-  
29 cordance with Section 3 (c) of Article III of the Enrollment Ordi-  
30 nance; give notice of this Council's determination in accordance with  
31 Section 4 of Article III of the Enrollment Ordinance; and place the  
32 names of each applicant upon the membership roll of the Tohono O'odham  
Nation in accordance with Article V of the Enrollment Ordinance.

The foregoing resolution was passed by the Tohono O'odham Council on the 2nd  
day of July, 1986, at a meeting at which a quorum was present with a vote of  
1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers

1 vested in the Council by Section 1 of Article II and of Section 1 (h) of  
2 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
3 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
