1 WHEREAS, the Plan of Operation of the Papago Tribal Utility Authority provides
2 that the Tohono O'Odham Council shall appoint the directors of
3 P.T.U.A. upon expiration of said term; and

5 WHEREAS, the terms of Johnnie Raley and Alfred Williamson expire on June 30,
6 1986; and

7 WHEREAS, the Plan of Operation requires that four members must have not less
8 than ten years experience in business management; and


9 WHEREAS, Mr. Raley and Mr. Williamson fill two of those positions, and

10 WHEREAS, the P.T.U.A. Board of Directors have recommended the reappointment
11 of Mr. Raley and Mr. Williamson for three year terms to expire on June
12 30, 1989.


14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that Mr. Raley and
15 Mr. Williams be reappointed to the P.T.U.A. Board of Directors for a
16 three year term to expire on June 30, 1989.

19 09th day of July, 1986, at a meeting at which a quorum was present with a vote
20 of 1581.5 for; -0- against; 58.5 not voting; and -01- absent, pursuant to the
21 authority vested in the Tohono O'Odham Council by Section 1 (f) of Article VI
22 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
23 Nation on January 18, 1986, and approved by the Acting Deputy Assistant
24 Secretary- Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
25 of the Act of June 18, 1934 (48 Stat. 984).
