

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sif Oidak District Budget FY 1987)

RES. NO. 357-86

1 WHEREAS, The Sif Oidak District Council has considered and reviewed its
2 proposed activities for FY 87 and prepared a budget to cover
3 anticipated cost and expenses; and

4 WHEREAS, The Sif Oidak District Council did by Resolution No. 05-86 approve
5 the proposed budget for FY 87 in the amount of \$163,674.47 said
6 budget period to begin on August 01, 1986 and end on July 31, 1987.

7 WHEREAS, The Sif Oidak District maintains an account at the First Interstate
8 Bank, Casa Grande and has authorized the following officers of the
9 Council to have authority to sign checks on the Account, the Chair-
10 man, Vice-Chairman and Secretary.

11 WHEREAS, The Sif Oidak District Council has sufficient funds in its IIM
12 Account to cover the proposed budget; and

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does
15 hereby approve the attached FY 87 budget of the Sif Oidak District
16 and authorizes expenditures in accordance therewith;

18 BE IT FURTHER RESOLVED by the Tohono O'Odham Council that it does hereby
19 authorizes the Sif Oidak District to maintain a separate District
20 Account with the First Interstate Bank of Arizona, Casa Grande,
21 Arizona, which shall provide that any of the following officers of
22 the District Council, i.e., the Chairman, Vice-Chairman and Secre-
23 tary be the signers

24 BE IT FURTHER RESOLVED that the Tohono O'Odham Council does hereby give
25 authority to the Sif Oidak District to transfer funds on deposit in
26 the District's IIM Account into an account with the First Interstate
27 Bank of Arizona in Casa Grande, an amount not to exceed one half of
28 the total District budget, \$81,837.24 and remainder to be transferred
29 when needed to meet the District's budgeted expenses.

30 The foregoing Resolution was passed by the Tohono O'Odham Council on the 09th
31 day of July, 1986, at a meeting at which a quorum was present with a vote of
32 1,640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
authority vested in the Council by Section 1 (d) of Article VI of the Consti-
tution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on

1 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
2 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
Act of June 18, 1934 (48 Stat. 984)
