3 in the amount of \$77,749.40; and


4 WHEREAS, the Pisinemo District has sufficient funds in its I.I.M. Account to

7 approves of same.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it does here-

15 for; 169.0 against; -0- not voting; and -0- absent, pursuant to the powers
16 vested in the Council by Section 1 (d) of Article VI of the Constitution of the
17 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
