

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Transferring of BIA Buildings)

RES. NO. 360-86

1 WHEREAS, the Bureau of Indian Affairs, Tohono O'Odham Agency has 11 buildings  
2 which are in the process of preparing a contract to demolish, locate  
3 at the BIA Agency Compound, identified as Building Nos. 13, 15, 17,  
4 32, 34, 77, 78, 79, T128, 51, 52; and

5 WHEREAS, the BIA Tohono O'Odham Agency has offered said buildings to the Tohono  
6 O'Odham Nation with the provisions that said buildings be repaired  
7 and maintained; and


8 WHEREAS, the Tohono O'Odham Nation, Executive Branch has determined that said  
9 buildings are needed, and that the cost of repair of the buildings  
10 are minimal and could be utilized as office space for the Tohono  
11 O'Odham Nation programs.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that  
13 Buildings Nos. 13, 15, 17, 32, 34, 77, 78, 79, T128, 51, and 52 be  
14 transferred to the Tohono O'Odham Nation for the benefit of the  
15 Nation.

17 BE IT FURTHER RESOLVED by the Legislative Council that it hereby recommends  
18 that the Chairman and Vice-Chairman of the Nation, expedite any and  
19 all necessary paperwork to insure that said buildings are turned over  
20 to the Nation.

22 The foregoing Resolution was passed by the Tohono O'Odham Council on the 10th  
23 day of July, 1986, at a meeting at which a quorum was present with a vote of  
24 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers  
25 vested in the Council by Section 1 (f) and (i) of Article VI of the Constitu-  
26 tion of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
