are minimal and could be utilized as office space for the Tohono						
O'Odham Nation programs.						
NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that						
Buildings Nos. 13, 15, 17, 32, 34, 77, 78, 79, T128, 51, and 52 be						
transferred to the Tohono O'Odham Nation for the benefit of the						
Nation.						
BE IT FURTHER RESOLVED by the Legislative Council that it hereby recommends						
that the Chairman and Vice-Chairman of the Nation, expedite any and						
all necessary paperwork to insure that said buildings are turned over						
to the Nation.
