1 WHEREAS, the Tohono O'Odham Council has been advised of the personnel policy of
2 forfeiting annual leave earned in excess of thirty days; and


3 WHEREAS, Chief Judge has submitted to the Legislative Council his letter of
4 resignation effective immediately with a request for payment of
5 annual leave; and

6 WHEREAS, the Law & Order Committee has reviewed his annual leave request and
7 recommend payment of 240 hours of annual leave based on written
8 policy.



10 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby
11 direct the Personnel office to process the paperwork to pay 240 hours
12 of annual leave to Franklin Antone.

13 The foregoing Resolution was passed by the Tohono O'Odham Council on the 10th
14 day of July, 1986, at a meeting at which a quorum was present with a vote of
15 1408.0 for; 232.0 against; -0- not voting; and -0- absent, pursuant to the
16 powers vested in the Council by Section 1 (b) of Article VI of the Constitu-
17 tion of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
