

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Judge Franklin Antone's resignation)

RES. NO. 368-86

1 WHEREAS, the Chief Judge of the Tohono O'Odham Tribal Courts, Franklin Antone,
2 did submit, by letter dated May 29, 1986 to the Tribal Chairman Josiah
3 Moore, his resignation to be effective immediately.

4 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Council does hereby
5 accept the resignation of Chief Judge Franklin Antone effective
6 immediately.

7 The foregoing resolution was passed by the Tohono O'Odham Council on the 10th
8 day of July, 1986, at a meeting at which a quorum was present with a vote of
9 1222.0 for; 418.0 against; -0- not voting; and -0- absent, pursuant to the
10 powers vested in the Council by Section 3 and 4 of Article VIII of the Consti-
11 tution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
12 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
13 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
14 of June 18, 1934 (48 Stat. 984).
