

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Fire Protection for San Lucy)

RES. NO. 369-86

1 WHEREAS, the Tohono O'odham Nation entered into a agreement
2 with the Town of Gila Bend, a copy of which is at-
3 tached hereto, wherein the Town of Gila Bend agreed to
4 provide fire protection to the village of San Lucy at
5 a yearly cost of \$75.00 per primary unit with 77 units
6 presently situated in San Lucy village or a total cost
7 of \$5,775.00 pe year; and

8 WHEREAS, under the terms of this agreement the Nation must
9 notify the Gila Bend Town Council of its desire to
10 renew this agreement and the Town Council shall notify
11 the Nation in writing of its willingness to accept
12 such renewal; and

13 WHEREAS, the date of termination of this agreement is July 1,
14 1986, and unless timely renewal the village of San
15 Lucy will be without needed fire protection.

16 NOW, THEREFORE, BE IT RESOLVED, that this Council does hereby
17 authorize the renewal, for a one year period, that
18 certain contract between the Town of Gila Bend and the
19 Tohono O'odham Nation wherein the Town of Gila Bend
20 agrees to provide fire protection to the village of
21 San Lucy, a copy of said agreement is attached hereto
22 and made a part hereof.

23 BE IT FURTHER RESOLVED that, the Chairman immediately send
24 written notice to the Town Council of Gila Bend of the
25 Nations desire to renew said agreement for a period of
26 one year and to negotiate and execute all necessary
27 agreements, documents or amendments thereto to carry
28 out the purpose of this resolution.

29 The foregoing resolution was passed by the Tohono O'odham Coun-
30 cil on the 10TH day of JULY, 1986, at a meeting
31 at which a quorum was present with a vote of 1640.0 for; -0-
32 against; -0- not voting; and 01 absent, pursuant to the
powers vested in the Council by Section 1(d) of Article VI of
the Constitution of the Tohono O'odham Nation, adopted by the
Tohono O'odham Nation on January 18, 1986, and approved by the

3 1934 (48 Stat. 984).
