

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Transfer of Housing Improving Program and monies to
Papago Housing Authority)

1 WHEREAS, the Tohono O'Odham Nation of Arizona is supportive of the
2 Housing Improvement Program (HIP) under P.L. 93-638 contract with
3 the Bureau of Indian Affairs; and

5 WHEREAS, such operations have been beneficial to the Tohono O'Odham Nation and
6 its people; and

7 WHEREAS, the Tohono O'Odham Legislative Council does desire to continue with
8 provision of these services during FY 1985 and subsequent years; and

9 WHEREAS, the Tohono O'Odham Legislative Council does endorse the Housing
10 Improvement Program (HIP) being administered by the Papago Housing
11 Authority which was established by ORD. NO. 56-77

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
13 it does hereby transfer to the Papago Housing Authority perpetual con-
14 tracting authority with the Bureau of Indian Affairs under federal
15 regulations and procedures for the provision of services entitled
16 Housing Improvement Program (HIP).

18 BE IT FURTHER RESOLVED that the Housing Improvement Program (HIP) selection
19 criteria will remain the same as previously approved by the Tohono
20 O'Odham Council.

22 AND BE IT FURTHER RESOLVED that all funds for Housing Improvement Program (HIP)
23 shall be kept in the Papago Housing Authority Accounts.

24 BE IT FURTHER RESOLVED that the Board Chairperson, Vice-Chairperson and exec-
25 utive Director of the Papago Housing Authority is hereby authorized to
26 negotiate and execute these contracts and any amendments thereto for
27 the duration of the contracts.

28 The foregoing Resolution was passed by the Tohono O'Odham Council on the 10th
29 day of July, 1986, at a meeting at which a quorum was present with a vote of
30 874.0 for; 206.5 against; 559.5 not voting; and 01 absent, pursuant to the
31 powers vested in the Council by Section 1 (b) and c (2) of Article VI of the
32 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
