

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Abolish Standing Committee of this Council)

RES. NO. 375-86

1 WHEREAS, The Tohono O'odham Council did on May 1, 1985 overrule the San Xavier
2 District Council approving the Master Lease with Santa Cruz Properties,
3 Inc., unless and until fair and equitable terms are negotiated between
4 all affected parties; and

6 WHEREAS, The Legislative Council did establish the Standing Committee by Reso-
7 lution No. 344-85; and


8 WHEREAS, The Standing Committee was charged with the responsibility to represent
9 the Tribe's interest in any negotiations with Santa Cruz Properties,
10 Inc.; and

11 WHEREAS, There is discontention in the performance of the Standing Committee.


12 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the Standing
13 Committee of this Council be abolished, and released from the
14 responsibility it is charged with.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 4th day
17 of August 1986, at a meeting at which a quorum was present with a vote of
18 470.0 for; 854.5 against; 315.5 not voting; and 02 absent, pursuant to the
19 powers vested in the Council by Section 1 (b) of Article VI of the Constitution
20 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
