

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To override veto of Resolution No. 304-86)

RES. NO. 378-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 304-86
2 adopt Option B with a Council calendar and compensation, to provide for
3 five Legislative meeting days per month (or fifty days per year) and
4 130 Committee meeting days per year and, to receive compensation in the
5 form of a salary; and

6
7 WHEREAS, Upon presentation of Resolution No. 304-86 to the Chairman of the
8 Tohono O'odham Nation he did disapprove thereof and returned it to the
9 Council with his objections in accordance with the provisions of
10 Article VII, Section 5 of the Constitution of the Nation; and

11 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
12 ation again voted to pass Resolution No. 304-86.

13 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
14 Chairman's veto of Resolution No. 304-86, by a vote of two-thirds (2/3)
15 of the votes cast.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
18 day of August, 1986, at a meeting at which a quorum was present and, by a vote
19 of 1037.0 for; 422.0 against; 181.0 not voting; and -0- absent, did override
20 the Chairman's veto of Resolution No. 304-86, pursuant to the powers vested in
21 the Council by Section 5 of Article VII of the Constitution of the Tohono
22 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
24 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
25 984).
